- 1. I will only use the school's computers and systems for schoolwork, homework and as directed.
- 2. I will be responsible for my behaviour when using the Internet. This includes resources I access and the language I use.

3. I will ask for permission when bringing files into school (on removable media or online) or ask permission to uploadappropriate material to my workspace.

- I will only edit or delete my own files and not view, or change, other people's files without their permission. I will
 respect otherpeople's privacy.
- 5. I will keep my logins, IDs and passwords secret and I will only log on to the school network/ learning platform with my ownusername and password.
- 6. I will respect the privacy and ownership of others' work on-line at all times.
- 7. I will use the internet responsibly and will only visit web sites approved by the school. I am also aware that during lessons Ishould visit websites that are appropriate for my studies.
- 8. If I bring a personal mobile phone to school, I will only do so, and will only use it, in linewith these conditions (conditions may be relaxed with the agreement of and under the supervision of a member of staff):
 - a. I will ensure that my mobile phone will be switched off and hidden from view at all times during the school day.
 - b. I will not make or receive phone calls, or use text or messaging facilities, at any time during the school day including atbreak and lunchtime. I know that if my parents wish to contact me urgently, they can telephone the school and a member of the office staff will ensure the message is passed on.
 - c. I will not use mobile devices in lessons or during lesson changeover, without the express permission of the teacher. I will put headphones away at the start of the school day.
 - d. I will not take pictures or videos at any time when in school or on a school activity.
 - e. The contents of my mobile devices will be suitable for viewing at school; there will be nothing on it that I would beembarrassed for staff in the school to see.
 - f. I accept that staff may ask to see contents should there be any concerns.
 - g. If a member of staff asks for a mobile device because it is used inappropriately, I will hand it over immediately and without argument.
- 9. I will not bring a laptop, tablet or smart watch to school without specific written permission from the school.
- 10. I will not attempt to bypass the internet filtering system.
- 11. I will not use apps or Artificial Intelligence that interfere with learning or could lead into accusations of cheating.
- 12. I will never use Artificial Intelligence to produce work required to be my own.
- 13. I will only e-mail people I know, or those approved by my teachers, and I will only use my school email address.
- 14. The messages I send, or information I upload, will always be kind.
- 15. Images of students and/ or staff will be taken, stored and used for school purposes only in line with school policy and notbe distributed outside the school without the permission of the Headteacher.
- 16. Unless a trusted adult has given permission, I will not give my home address, phone number, send photographs or video, orgive any other personal information that could be used to identify me, my family or my friends.
- 17. I will not share information about school or use pictures of students in school uniform without permission from a teacher.
- 18. I will not give out any personal information such as name, phone number or address. I will not arrange to meet someoneunless this is part of a school project approved by my teacher.
- 19. I will never arrange to meet someone I have only ever previously met on the internet or by email or in a chat room, unless Itake a trusted adult with me.
- 20. If I see anything I am unhappy with or I receive a message I do not like, I will not respond to it, but I will save it and talk to ateacher/trusted adult.
- 21. I am aware that some websites and social networks have age restrictions, and I will respect this.
- 22. I will not use any social media apps or websites until I am at least 13. I will always seek my parents' permission before creating an account.
- 23. I am aware that, at all times, my online activity should not upset or hurt other people and that I should not put myself or others at risk.

I have read and understood the above and agree that these choices of behaviour are designed to keep everybody safe. I agree to them and accept that if they are not followed, school sanctions may be applied, and my parent/carer may be contacted.
